Midlands Evidence Repository (MIDER)

We manage the Nottingham and Nottinghamshire Primary Care collection within the [Midlands Evidence Repository \(MIDER\)](#).

MIDER is the result of a merger between the East Midlands Evidence Repository (EMER) and the West Midlands Evidence Repository (WMER). It serves as the institutional research repository for 21 NHS Trusts across the Midlands and is managed by a consortium of Midlands NHS Knowledge and Library Services. Its purpose is to enhance the visibility and discoverability of NHS research by capturing, storing, and providing access to research outputs and other non-traditional publications produced by NHS organisations in the region. Wherever possible, full-text publications are made available through open-access, and the repository continues to expand as new collections are added. The site is freely available, and no login is required.



MIDER allows you to search by research area of interest or by NHS organisation. You can also search by author, subject, journal, date, and more. Author profiles can also link to existing ORCID researcher profiles.

If you are a researcher, it is an ideal place to showcase your work and make it more easily searchable and accessible to colleagues across the Midlands, the NHS and internationally.
